Lois Anderson moved to close nominations. Larry Jackson seconded. Motion passed as follows: Crenshaw, Hickman, Egli, Jackson, and Anderson in favor with McLeod and Maghan absent.

Lois Anderson moved to recommend that Council appoint Ashley Wenger, Jill Bonney-Hill and Sherrie Gottfried to positions #5, #6 and #7 respectively on the Keizer Points of Interest Committee; terms beginning December 1, 2015 and ending November 30, 2018. Larry Jackson seconded. Motion passed as follows: Crenshaw, Jackson, Head and Anderson in favor with Egli, Hickman and Maghan absent.

Ashley Wenger withdrew from consideration for the Planning Commission.

Planning Commission (Two Vacancies)

Larry Jackson moved to recommend that Council appoint Josh Eggleston to position #6 on the Keizer Planning Commission, term to begin at the next Planning Commission meeting and end September 30, 2018. Sarah Head seconded. Motion passed as follows: Crenshaw, Jackson, Head and Anderson in favor with Egli, Hickman and Maghan absent.
