FLAG SALUTE

Mayor Clark led the pledge of allegiance.

**SPECIAL ORDERS
OF BUSINESS**

**a. Volunteer of the
Quarter Award -
Robin Richmond-
Barney**

Mayor Clark shared that *Robin Richmond-Barney* has been involved with almost every event in Keizer, such as River Fair, the Chamber of Commerce, the City's 40th Birthday, and many more. If there was an event, it was her organizational and communication skills, along with her ability to work with everyone in the community that made all of the events successful. Her influence on the community had been fantastic.

Councilor Kohler commented about working with Ms. Richmond-Barney on the 40th Birthday Party for the City of Keizer noting that she wanted to do everything and quickly executed tasks. She took care of things the way she was asked and would contribute even more. She did more than most people may know in making successful events.

Councilor Reid shared that she was on the team to plan the 40th Birthday for the City of Keizer. She shared that without Robin Richmond-Barney, the

pieces would not have come together as efficiently as they did. The turnout was huge and successful because of her.

**b. Swearing in of
Chief of Police
Andrew Copeland**

Mayor Clark shared that there was an official swearing in ceremony for Chief Copeland the previous Friday.

Chief of Police Copeland expressed his gratitude and shared his passions, which included his faith, his family, policing, and football. He shared a story about treating others with love and respect on the worst day of their life. The Keizer Police Department would treat the community with love, and respect, be fair, and with transparency.

Mayor Clark read the Proclamation for Indigenous Peoples' Day.

**d. PROCLAMATION
- Domestic
Violence
Awareness Month**

Paige Clarkson, Marion County District Attorney, stated how important the work related to Domestic Violence was. She shared that in 2022, over 700 domestic violence cases were filed. For each one of those, there are many who choose not to report or call do not feel safe in their own homes, and are isolated from family and friends because of the abuser. She shared that it matters to bring awareness to the community. She expressed appreciation for the expert work of Ms. Jayne Downing and their partnership.

Jayne Downing, Executive Director of the Center of Hope and Safety, introduced Maxwell, a black service animal for the Center. They have had an incredible relationship with Police Chief Copeland who has been serving on the domestic violence response team for many years. She shared about the numbers of people they had served noting they had approximately 36,000 contacts last year and an estimated 4,000-7,000 people were served every year by their program. They provide a 24-hour bilingual line, shelter, walk-in services, and support groups. They have provided more than 18,000 nights of shelter through Project Turnkey. She shared some of the success related to their services and shared a story about an advocate who wrote about Maxwell serving a family.

Mayor Clark read the Domestic Violence Awareness Month Proclamation.

**e. PROCLAMATION -
National Disability
Employment
Awareness Month**

Tammy Kunz, Keizer Resident, shared information on National Disability Employment Awareness Month. She shared that Americans observe National Employment Awareness Month by paying tribute to the accomplishments of men and women with disabilities whose work helps keep the economy strong by reaffirming their commitment to ensuring quality and opportunity for all citizens. She added that everyone had value in the workplace and commented on the importance of accommodation, diversity, equality, and inclusion.

Mayor Clark read the National Disability Employment Awareness Month.

COMMITTEE REPORTS

Rhonda Rich, President of West Keizer Neighborhood Association, provided a report. She noted the speed table on Cummings Lane and shared the positive feedback from the principal of Cummings Elementary School. She shared when their upcoming meetings would be held.

Matt Lawyer, Keizer Planning Commission Chair, met on September 20th for training on rules and regulations related to the Planning Commission.

Mr. Lawyer thanked City Attorney Shannon Johnson, Planning Director Shane Witham, and Assistant Planner Dina Horner for their work for the Planning Commission, being responsive and doing good work. Mr. Lawyer recognized the Youth Liaison Angelica Sarmiento Avendano.

a. Volunteer Coordinating Committee Recommendations for Appointment - Keizer Budget Committee and Keizer Planning Commission.

Assistant City Manager Tim Wood reviewed the Staff Report, which included appointment recommendations from the Volunteer Coordinating Committee.

Mayor Clark commented that at the Volunteer Coordinating Committee meeting, there were some differences as to understanding how the voting process should work. A team met to review the process and an updated process would be discussed and adopted in the future. She thanked Deputy City Recorder Dawn Wilson, City Manager Adam Brown, and City Recorder Melissa Bisset for reviewing all of the iterations of the appointment process.

She expressed appreciation for the work of the volunteers of this committee. Mayor Clark commented on procedural difficulties, and none of them were due to the volunteer applicants or other committees.

It was noted that the City needed to have good recordings of the meetings.

Councilor Reid moved that Council accept the recommendation of the Volunteer Coordinating Committee and appoint Elaine Wilson, Jane Herb and Lore Christopher to positions 3, 4 and 5 respectively on the Keizer Budget Committee, for terms expiring August 31, 2026, and appoint Fernando Lopez and Robb Witters to positions 4 and 5 respectively to the Keizer Planning Commission, for the terms ending September 30, 2026.

Seconded by Councilor Kohler. Motion passed unanimously as follows:

PUBLIC COMMENTS

Four letters were submitted by Tammy Kunz, Keizer Resident, on traffic concerns; Dana L. Petre-Miller, Keizer Resident, on fossil fuels in buildings; Debra Randolph, Keizer Resident, on the City of Keizer sign and planter, which was in the City of Salem; and Steven Thierman on the Heritage and Historical Tree Program.

Kaylee Hanson, President; *Pawat Potisuk*, Vice President; *Reesa Ramirez*,

Public Relations Officer; and *Pawit Potisuk*, Historian, of the National Honor Society asked the City Council to be judges on Sunday, October 29th, at their annual Trunk or Treat. Mayor Clark commented on the fun and thanked them for the event. Councilor Reid and Councilor Cross would be available to attend.

David Rheinholdt, President, and *Angolina Martinez*, Director of Operations, of the Latino Business Alliance spoke about Expo Negocio, an annual event to help new or existing businesses to attend classes. It was an all-day event in the Civic Center where there would be free food, no expense for the public, and everyone was welcome to attend. They requested rental assistance from the City. Mayor Clark noted it was a fantastic event.

- a. **Latino Business Alliance 2023 Expo Negocio - Community Center Fee Waiver**
- Assistant City Manager Wood reviewed his Staff Report. The total fees were a \$2,500 use fee and a \$1,500 refundable deposit for a total of \$4,000.
- Discussion ensued regarding formalizing a policy related to the collection of the refundable deposit.

It was noted that the request was to waive the use fee of \$2,500.

Councilor Reid moved the City Council approve a Waiver for the Community Center Use Fee for the Latino Business Alliance 2023 Expo Negocio on November 9, 2023. Seconded by Councilor Kohler. Motion passed unanimously as follows:

- City Councilor Juran declared a potential conflict of interest since his son had asked for it to be brought up.
- City Attorney Johnson reviewed the Ordinance amendments.
- Discussion ensued regarding the designee and the different types of vendors.
- Councilor Reid moved that the City Council adopt Ordinance No. 2023, Establishing Keizer Parks Regulations; (Repealing Ordinance No. 2018-791, Ordinance No. 2022-846 and Ordinance No. 2023-857) as updated by the City Attorney with the version on the Dias. Seconded by Councilor Kohler.

- Councilor Husseman proposed a Friendly Amendment to Sections 27 sub

Fees; Repealing Resolution R2019-2978 17, 18, and 24, to raise each fine to \$200 from the existing \$150. Councilor Reid as the Mover, did not accept the Friendly Amendment.

Councilor Husseman moved to amend Sections 27, sub 17, 18 and 24 to raise each fine from \$150 to \$200. Motion died for lack of a second.

The original Motion that the City Council adopt Ordinance No. 2023, Establishing Keizer Parks Regulations; (Repealing Ordinance No. 2018-791, Ordinance No. 2022-846 and Ordinance No. 2023-857) as updated by the City Attorney with the version on the Dias was voted on. 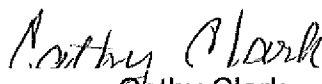

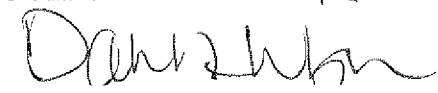

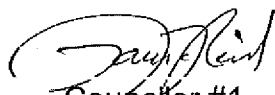
